- LARIAC 7 is scheduled to begin in January 2023. Contract amendments and Board Notices for LARIAC 7 are being processed
- 41 entities have confirmed their intent to participate in LARIAC 7 (either via a Letter of Intent or a signed Participant Agreement) representing approximately \$4.3M in funding resources.
- USGS BAA application for financial assistance for LiDAR collection
- Initial docs for Street-Level Imagery & LiDAR RFP have been completed and will be submitted to ISD contracts to move forward with the process
- We will start the RFP process for the Frequent Image Capture program.
